6.2 Fox Creek WWPS Upgrade – Engineering Design Award

Motion: To proceed immediately with the design and preparation of contract documents for the construction of an 810 meter portion of the proposed forcemain on Fox Creek Road as part of a City road upgrading project, and to award the engineering work to Roy Consultants as having been mandated by the City of Dieppe to carry out design and construction management for the road upgrading, and to complete the work in accordance with the letter proposal from Roy Consultants dated Jan 13, 2017 with fees totaling \$17,000 for design and contract documents and \$3,000 for as-Built drawings. It is further approved that the forcemain construction will be coordinated with the roadway construction activities planned for 2017 and the work tendered within the City contract and managed by the City. The cost of construction and the commission's share for the engineering fees associated with construction will be recovered on the basis of actual costs and in accordance with the Bourque Road Forcemain Project Sub-Agreement between the Commission and the City.
