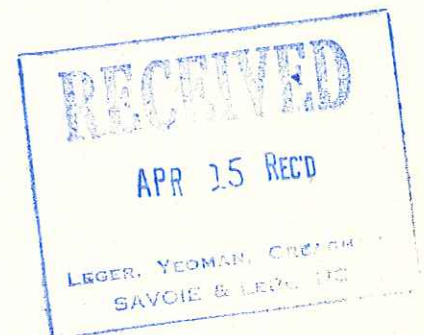
As requested in our telephone conversation of yesterday, I have formally asked a solicitor in the Department of Justice for information on conflict of interest.

Attached is a copy of Order-in-Council No. 83-162, dated March 3, 1983, which establishes the Greater Moncton Sewerage Commission. The order-in-council provides details of the jurisdiction and powers of your Commission.

The establishment of the Commission is another milestone in the work that has been undertaken over the years to develop proper sewage collection and treatment facilities for the City of Moncton and the Towns of Dieppe and Riverview. On behalf of the Government, may I extend appreciation to you and all other members of the Commission who have agreed to undertake this very important task.

As the Commission commences its initial efforts, I am sure you will wish to consult with officials of this Department who have experience in the details of developing major sewage projects, as well as some special problems that occur because of the fact that you are a commission rather than a municipality. In this regard, Moncton is the sixth commission that has been established for this purpose, although only four others are still active.

The Deputy Minister, Mr. Brian Barnes, is familiar with some of the special problems that occur because of the establishment of a commission. Mr. David Silliphant, Director of the Pollution Control Branch, has been actively



83 - 162

1. Under section 15.2 of the Clean Environment Act, the Lieutenant-Governor in Council appoints a board of the following members:
 - (a) Ronald J. LeBlanc of Moncton as Chairman;
 - (b) Fred W. Hutchinson of Moncton as Vice-Chairman;
 - (c) Stephen C. Campbell of Moncton;
 - (d) John Nagle of Riverview;
 - (e) Claude Savoie of Dieppe; and
 - (f) Jack Stultz of Moncton.
2. The said Board is constituted a Corporation.
3. The name of the Board is the Greater Moncton Sewerage Commission.
4. The members of the Corporation shall hold office during pleasure of the Lieutenant-Governor in Council.
5. The Corporation shall have all the powers contained in subsection 15.2(2) of the Clean Environment Act, along with the duties and powers of a company under the Business Corporations Act.

6. The Corporation shall be exempt from the provisions of the Public Utilities Act.

7. The Corporation is granted authority to pass such by-laws as are deemed necessary for the proper operation of the Corporation.

8. A secretary shall be elected at the first duly constituted meeting of the Corporation.

9. Each member of the Corporation, including the Chairman, shall have one vote and, in the case of an equality of votes, the Chairman shall have the casting vote.

10. Members of the Corporation shall serve without remuneration except for vouchered expenses as determined by the Corporation by by-law.

11. The assets of the Corporation shall be those assets which are constructed or acquired by the Commission subsequent to the date of this Order in Council.

12. The Corporation shall have jurisdiction for construction and operation of trunk collector sewers, pumping stations and sewage treatment facilities in the area bounded on the west by the Wheeler Boulevard Findlay Boulevard Causeway along both sides of the Petitcodiac River easterly to Mill Creek in the Town of Riverview and Steeves Creek in the Town of Dieppe including the area at the mouth of Halls and Humphrey Creeks as far as Church Street on Halls Creek and the

Lewisville Road on Humphrey Creek as more specifically delineated by the heavy solid lines drawn on the attached Schedule 'A'.

13. The Corporation shall have jurisdiction to intercept and convey sewage from sewers owned by the City of Moncton and the Towns of Dieppe and Riverview and does not have authority to provide sewer service to any other property owner except with the written permission of the Council of the municipality within which the property is located.
