## 6. Business Matters

### 6.1 GMWC Landscaping Weed Control Program

K. Rice presented a report outlining the outlining the pros and cons of each weed control program option for the Commission's consideration. The Commission gave direction to no longer use pesticides on TransAqua's properties and to develop signage ("This lawn is pesticide free") to be placed on the WWTF lawn each spring.

### 6.2 Symposium de la rivière Petitcodiac River Symposium sponsorship

Sentinelles Petitcodiac Riverkeeper was seeking a \$2,500 sponsorship that would allow TransAqua to have a display booth. The cost of the symposium is \$6,000. Other sponsors are not known. This is the first symposium of its kind and some environmental groups (i.e. Fundy Biosphere Reserve) were not invited. TransAqua sponsoring 42% of the total cost does not make sense. TransAqua is willing to sponsor \$500 and request no display booth and for its logo to be displayed at the same size as other organizations. Commissioner Desjardins declared a conflict and left the Public Meeting for this Item.
