### 5.1 Chair Desjardins – Increasing Communications with the public

Chair Desjardins submitted information to the Commissioners prior to this meeting suggesting that increased public awareness surrounding citizens who use their toilets as garbage cans. The Chair also suggests establishing a public event in collaboration with local environmental groups to celebrate the milestone surrounding the completion of the Upgrade Project and the removal of the causeway connecting Riverview to Moncton. Other comments included hiring a communications person, should the Commission lead the communications initiative, hire a communications firm, do a survey, continue with the 3 P's message (pee, poo and toilet paper only down the drain), apartment buildings don't get the water and sewer bills with any bill stuffers like the Sewer Do's and Don'ts Brochure. The Commission is requesting the GMWC Communications Strategy and Implementation Plan information at a future Commission Meeting. K. Rice suggests he will contact the NB Department of Education for the GMA to inquire about presenting at each school in our region annually for grade 5 or 6 students.

### 5.2 Secretary Gagnon – Community Project Partnership with the City of Dieppe

Secretary Gagnon met with the Dieppe Mayor and CAO who indicated Dieppe's interest in working together on a community project such as what is happening with the Riverview Light-Up program for the holidays. In due course in the New Year, the General Manager will contact the Dieppe CAO to discuss and set up a meeting if there is a positive response. An eventual meeting on this topic should also include, if available, the Commissioners representing Dieppe (Secretary Gagnon and Commissioner Ouellette) and Chair Desjardins.
