1. Chair's remarks and Approval of Agenda

4. <u>Capital Construction Program, Engineering Studies</u>

4.1 Capital Projects

4.1.1 <u>Capital Construction Program 2014 - Progress Report</u>

B. LeBlanc presented the updated spreadsheet entitled GMSC 2014 Capital Program - Projects in Planning/Pre-Design/Design Phase. He then opened the floor to questions and/or comments concerning its content.

Several questions asked were clarified by B. LeBlanc.

4.1.2 Gantt Chart - Schedule of 2014 Major Capital Projects

The chart was reviewed. B. LeBlanc advised that everything is moving according to plan. He indicated a lot of capital money budgeted may not be used this year as we are waiting for a decision as to whether we are going P3 or Building Canada or on our own.

4.1.3 CBCL Biological Treatment Project Update

B. LeBlanc advised that following discussion with CBCL he was informed that we will receive the final report at the end of September.

4.2 Equipment and Contracts - Recommendations and Awards

4.2.1 Web site updating and branding development - Award

This item moved to the Private Meeting agenda.

4.2.2 <u>Compost Facility Site Work RFQ - Enclosure (GMWC-COMP 2014-001)</u> <u>Award</u>

B. LeBlanc presented the GMWC Compost Facility 2014 Construction Program Status Report. He indicated three bidders were invited to submit quotations but only two submitted bids. The summary of the projects, the design status, construction status and amounts budgeted were reviewed.

Discussion followed and questions asked were clarified.

It was **Moved By:** C. Sweetland and **Seconded By:** J. Thériault to ratify the recommendation of management to accept Modern Construction (1983) Ltd. for this project.

4.2.3 <u>Compost Facility Site Work RFQ - Walkway (GMWC-COMP 2014-03)</u> <u>Award</u>

A copy of a letter dated August 6, 2014 received from R.V. Anderson was circulated for information purposes.

4.3 Engineering Studies/Reports

4.3.1 <u>Future Conveyance and Combined Sewer Overflow Strategy RFP 2014-04</u> <u>Recommendation</u>

B. LeBlanc presented the Proposal Evaluation GMWC Future Conveyance and Combined Sewer Overflow Strategy Report. He advised that 5 proposals were received and evaluated by a committee made up of Management, Technical and Financial personnel of the Commission and

that 4 proponents were further evaluated by a presentation and interview.

The report was reviewed in detail and considerable discussion followed. Questions asked were clarified by B. LeBlanc.

It was **Moved By:** D. Bourgeois and **Seconded By:** C. Michaud that RV Anderson be awarded the contract for the development of the Future Conveyance and Combined Sewer Strategy for the GMWC per RFP 2014-04 at a cost of \$214,120.00 plus HST. **CARRIED**

5. Financial and Administration

5.1 Monthly Financial Report - July 2014

The financial report was reviewed. B. LeBlanc highlighted some items in the financial report for the year to date and the month.

5.2 Investment update

B. LeBlanc presented a memo dated 19 August 2014 with respect to Investment Recommendations and Discussion. He outlined the existing investment and the current investment opportunity. He advised that GMWC does not currently have an investment policy and indicated that this is something that should be developed.

Considerable discussion followed. C. Michaud advised that an investment policy should be put in place as soon as possible. All present were in agreement with this suggestion.

Management will meet with C. Michaud to prepare a draft policy which will be presented to the Commission at its September meeting.

6. Other - General

6.1 General Manager Report - August 2014

The report was reviewed and B. LeBlanc provided some further details on the highlighted points.

B. LeBlanc applauded the Chair, C. Sweetland and the Board for being able to arrange meetings, on very short notice, with MLA's and MP's immediately following last month's Commission meeting.

D. Bourgeois expressed appreciation to B. LeBlanc for his excellent efforts in providing such detailed and comprehensive reporting to the Commission. All present were in complete agreement with this comment.

6.1.1 Compost Site Open House date

B. LeBlanc circulated a memo entitled Proposed/Revised Branding Launch Approach and Key Dates.

The key dates, timing and events items were reviewed. Following discussion it was agreed that the key stakeholder brand launch and breakfast to be rescheduled between the dates of October 1st and 3rd.

6.1.2 Compost Site Business Case

B. LeBlanc presented a Compost Site Business Case report with respect to the Delong Drive Composting Facility.

The report was reviewed and discussed in detail. Questions asked were clarified by B. LeBlanc.

It was **Moved By:** D. Bourgeois and **Seconded By:** J. Thériault that the GMWC issue an RFP in the winter months for the bulk sale of some or all of the 2015 production of the GMWC compost, including options where we could share in the revenue from the sale of top soil and/or allow proponents to "mix the product" at our site and distribute it for sale.

6.1.3 Atlantic Industrial Services EIA Update

B. LeBlanc informed the Commission that Atlantic Industrial Services (AIS) applied for an Environment Impact Assessment (EIA) and GMWC received notice of this on June 10, 2014.

As part of the EIA process, the GMWC put forward its comments on June 26, 2014.

A report detailing the response to the first round of EIA questions was circulated. B. LeBlanc advised that the GMWC has to respond to the province on the EIA by August 27, 2014.

Considerable discussion followed.

B. LeBlanc together with management will provide the Commission at its September meeting with some recommendations on the legal issues and how the GMWC should handle this matter.
